APPRENTICESHIP TUITION APPLICATION PROCESS

- Application for Tuition Assistance must be submitted to the Training Centre for approval before the commencement of Apprenticeship Training for each Training Period.
- Applicants must be members in good standing of IBEW Local 424 or recognized Permit holders and/or Travelers (DUES MUST BE PAID UP TO DATE).
- Applicants must be eligible for Education Trust Fund Benefits at the time of commencement of Apprenticeship Training.
- Applicants must agree to repay the financial assistance to the Trust Fund, if they do not maintain IBEW membership for five years after receipt of the assistance.
- Applicants must be current with C.S.T.S. and First Aid.
- Applicants must provide tuition receipt, record of successful completion of Apprenticeship Training, (Branch Marks from the Apprenticeship Board) and have successfully completed the required Supplementary Training as noted above within six months of completion of Apprenticeship Training. Tuition Assistance is then forwarded to the applicant.
